RULES FOR EVENT:

- PARTICIPANT: MAXIMUM OF 2 MEMBERS PER TEAM.
- SCORING: BASED ON THE NUMBER OF CORRECT GUESSES.
- TIME LIMIT: 30-60 SECONDS PER TURN.
- OBJECTIVE: GUESS THE WORD/PHRASE FROM EMOJIS WITHIN THE TIME LIMIT.
- ROLES: ONE PLAYER GIVES CLUES (WITHOUT SAYING THE ANSWER), THE OTHER GUESSES.
- GUESSING RULES: UNLIMITED GUESSES; THE CLUE GIVER CANNOT SAY ANY PART OF THE ANSWER.
